## MINUTES OF THE SALT LAKE ASTRONOMICAL SOCIETY BOARD MEETING

14 November 2018

Meeting called to order: 7:00 pm

November General Meeting

SLAS President John Johansen announced that next week's General Meeting is cancelled. This is due to possible low attendance due to it being the night before Thanksgiving.

Solstice Party

Solstice Party is Saturday, December 1. John and Leslie have managed to get several door prizes already from various retailers. John continues to do this. He also purchased an Orion Starblast 114mm Telescope from the Clark Planetarium at a discount price of \$223.00. Since Rodger reminded us that there are funds already earmarked for this party, no voting was necessary for this purchase. John wanted it also noted that Clark Planetarium employee Tom Sevcik donated a 12" Moon Globe to the door prizes. John also asked the board to vote if he should buy gift cards for the party. The vote was unanimous that he should.

Luke Moses suggested that the tickets for the door prizes be given to SLAS members only rather than every person. The ticket person will have a roster of the members. A vote was cast by the board and it was unanimous for this rule. This way more members have a chance at the prizes vs just a few members.

Rodger Fry noted that since there are major prizes and then the minor prizes, that we give 1 ticket to each member for the major prizes and they will be differently-colored tickets. This way there is more fairness in members getting the major prizes. The board voted and it was unanimous in the affirmative.

Budget

Since Jim Keane was absent, the new budget was not available for conversation. This will be talked over at December's Mandatory Transitional Meeting in lieu of printing it in the NOVA

for all members and then presenting it for approval to the general membership at January's General Meeting. Denise Larsen will email Jim requesting he send a copy to the entire board. Denise reported that, with our current budget, we are solvent in all of our accounts, with everything balanced.

#### SPOC Brochures

Rodger Fry handed out copies of the rough draft of these brochures. The brochure looks very attractive and is sure to draw more visitors to our wonderful observatory. Rodger will be making the following changes: "nebula" to "nebulae", making the SLAS logo smaller with the website underneath and the address will be taken off with the exception of the zip code The board voted in the unanimous on the changes. Once changes are made, he will then present the brochure to the Tooele County Commission for their approval. These will be distributed at truck stops along I-80 from Elko, NV to Evanston, WY. Since the budget for these brochures goes over the \$1200 grant he received from Tooele County, he asked the board to vote that he spend another \$800. Initially this will come from the SPOC fund but will ultimately come from the General fund. The board voted unanimously in the affirmative.

A short discussion was had about how to best accommodate him. Mike Clements has been contacted. Leslie confirmed availability for help with Rodger and John for this Saturday, the 17<sup>th</sup>.

### Davis County Library

John mentioned that Laurel Pederson of the Davis County Library has requested we do a star party. She doesn't know dates yet but John will refer her to Jim when these dates are given. She also mentioned interest in the Library Loaner Program but is wondering how this can be funded. More to come on this.

### Thank You Cards

John read two thank you cards. The first was from Capitol Reef, the second was from Corina Jachmann. Capitol Reef thanked the club for its continued support of Heritage Star Fest. Corina "thanked the club for our thoughtfulness, love and support on the sudden passing of Siegfried. He loved all the wonderful experiences he had with the club and was one serious astronomer. Officers' Reports Vice President Leslie Fowler will continue to promote the Solstice Party and coordinate the Random Acts.

Secretary/Treasurer Denise Larsen reported that all accounts are solvent and balanced. Due to Jim's absence, the new budget will be reviewed in December.

Board Member-at-Large Jim Keane was absent.

Board Member-at-Large Nate Goodman thanked everyone for their support in working with him over the past two years. John thanked Nate and a big round of applause was given for his work. He will continue to conduct the winter solar parties at the Natural History Museum. These will begin December 8 and will be every Saturday from Noon - 3pm, weather pending.

Tony Sarra reported that the next imaging session will be in January due to the holidays. The last session was successful with good attendance. He continues to send SLAS blasts of the images they study.

New Business Patrick suggested inviting the man who does the portable planetarium. Rodger noted that he is in contact with him and that he will show up again next season.

Patrick reminded us that at the transitional board meeting in December, we need to have both board and general meetings and star party schedules ready to present in lieu of the January General Meeting.

He also suggested to us, for formality reasons, that we should re-approve of the \$200 that can be spent without board permission. Patrick ended by asking who would be setting the star party schedule for next season. Siegfried usually did this. Rodger volunteered to do this. Since Nate and Dave have helped Siegfried in the past, Nate suggested to Rodger that they are willing to help again.
