John welcomed everyone, thanked everyone for attending. He then introduced the speaker, Dr. Anil Seth, a professor at the U of U's Department of Physics & Astronomy.

Proposed Amendments

John announced that the Board has amended three areas of the constitution. Article V, "Election and Voting Procedures", Section B, "The Election Process", Lines 1, 2 & 8 are the proposed amendments. See below for the amendments.

It will be noted here that Marlene Egger motioned for an amendment to the third amendment that the words "by secret ballot" be put in at the beginning of the third amendment. John Johansen seconded the motion and the vote was unanimous in the affirmative among the members present.

John read through each amendment and discussion was made. Patrick Wiggins then made the first motion that a vote be made. John Johansen seconded the motion. There were 24 votes in the affirmative to pass the amendments and 2 against the amendments. Aleta confirmed with John that she received no paper ballots. By the constitution, we need 2/3 majority vote and it was obtained.

The three amendments passed and Patrick Wiggins will be updating the constitution. Since passing these amendments means all members now have until 11:59 PM on August 31, 2019, to file their candidacy with the Secretary/Treasurer, Denise Larsen, Denise will be sending out a SLAS Blast informing members of this newly-extended timeframe.

#### Constitutional Committee

John announced that Marlene Egger has volunteered to head a newly-established constitutional committee. The mission of this committee is to come up with suggestions for bringing the club's constitution up-to-date with as few changes as possible.

The meeting was adjourned to Village Inn for "Advanced Training" at 9:05 pm.
